**Below please find details of procedure for tax deductible donations for Australia and USA and Stewardship for UK donations.**

Our application to join Global Development Group has been approved.

*Tax deductible receipts for gifts over \$2 with a preference for J674N KEP Gardens will be issued by Global Development Group (ABN 57 102 400 993), an Australian DFAT approved NGO carrying out quality humanitarian aid and development activities with approved partners and providing aid to relieve poverty and provide long term solutions. Excess funds will be directed to other approved project activities within Kep Gardens.*



Australian procedure:

1. Tax deductible donations can be sent or transferred by:

- **Cheque** payable to Global Development Group through mail to PO Box 651, Rochedale South, QLD, 4123.

Include on a separate note: total of the donation, J674N, donor name and address or email.

- **Credit card** (Master Card, Visa, American Express, Diners) through website [www.gdg.org.au/GiveToJ674N](http://www.gdg.org.au/GiveToJ674N) .

2. You will have to create an account with Stewardship UK (with Global Development Group Australia as your recipient) and put J674N KEP Gardens in the "reference" section as you complete your donation. (TIP: please remember your username, password and PIN).
